

## HIGHER LEVEL SKILLS STUDENT CONTRIBUTION FACT SHEET

### WHAT IS HIGHER LEVEL SKILLS?

The Higher Level Skills funding program supports eligible individuals to access one subsidised training place in selected certificate IV level and above qualifications, or priority skill sets. Funding under the Higher Level Skills Program is provided by the Queensland State Governments Department of Education and Training.

### STUDENT CO-CONTRIBUTION FEE

As part of the Higher Level Skills Program a student co-contribution fee must be collected. This fee can be paid by the student themselves or on behalf of the student by a third party. The applicable fee is paid upon enrolment and is the final & only fee the student must pay.

Co-contribution fees are not payable for units that are awarded a Credit Transfer. If you are awarded a Credit Transfer, you will be refunded the co-contribution fee paid for that unit.
